If the NSF from which you hold certifications is not listed, please complete the application and email all documentation that may be applicable to programs@sailing.ca, including an NSF reference or contact. Sail Canada continues to work with other NSFs to establish equivalency and may have a solution on hand already.

Successful applications will be subject to a \$100 CAD administration fee.

Notes for Applicants:

- Equivalency Applications are reviewed on a case by case basis and must be supported by copies of all relevant documentation.
- In all cases where certifications are granted, CANSail Instructors are required to meet and maintain prerequisite requirements.
- All CANSail Instructors are required to complete an Annual Instructor Registration with Sail Canada in order to be eligible to deliver training.
- Expired certifications will not be accepted as proof of equivalency.
- Once your Sail Canada profile is complete, you'll need to pay the administration fee for equivalency here
